REASONS

Council of Turkish Higher Education Actions

■WHO declared Covid 19 as a pandemic on a global scale (by on March 11).

☐ Council Of Turkish Higher Education declared A Road Map During Covid-19 and a period of digital, remote teaching in higher education started and it is still standing out.

NURSING PROGRAMS

NURSING PROGRAMS-CONTINUE

- Free 6 gb "distance education support" quota for university students was supplied by the government. 29.4.2020
- Finally Fall term of 2020 and in the spring term of 2021 the distance education continued





The Higher Education Quality Council (THEQC) acts

 Published Quality Assurance Criteria and Assessment Guide in Distance Education 2020.



The purpose of this guide is to shed light on the evaluation of the quality assurance processes regarding Distance / Blended Education practices implemented by the universities.

 As the nursing programs started to continue teaching via distance education HEPDAK not to interrupt the accreditation made a plan and prepared a statement to the respective programs as;



*The educational activites should be in compliance with the HEPDAK standarts



*Prepare an action plan in order to reach the program outputs

*Planning of teaching (theoretical/ clinical) and assessment-evaluation in line with the decisions taken by Higher Education Consulate and their own universities.

*Programs use distance education methods that will enable students to learn and reach the program outcomes.


*Theoretical and practical training on the COVID-19 issues should be integrated into the curriculum.



*Educators, and especially students at the graduation stage, must have the necessary competencies in COVID-19 epidemic and maintenance management, appropriate use of personal protective equipment, and transmission.

For practice training, online resources for simulation, virtual reality, clinical care teaching should be used effectively.

HEPDAK Plan for the Accreditation of Nursing Education Programs in the Covid Pandemic Process (04.05.2020)



Programs that carry out 1st, 2nd and 3rd grade students with the distance education methods should be repeated with supported content in next academic year with practice in health institutions and face-to-face training



These clinical experiences should enable students to achieve program outcomes.



HEPDAK Plan for the Accreditation of Nursing Education Programs in the Covid Pandemic Process (04.05.2020)



Gaining theoretical/clinical education skills and achieving program outcomes should be evaluated with appropriate assessment and evaluation methods.



Evidence showing "decision-making processes, how theoretical/clinical practice carried out, training of educators, assessment and evaluation and program outputs" regarding the planning and implementation should be presented.

 Distance education should be recorded and evidence should be presented. THE REASONS FOR THE DEISION OF REMOTE EVALUATION FOR ACCREDITATION

- ☐ Limitations of student opportunities for distance education
- ☐ The high number of nursing students (around 60,000) who will be adversely affected by the new educational environment
- ☐ To support the continuity of the existing accreditation processes.







Applicants for HEPDAK Accreditation

As of January 2020, the number of program applicants to HEPDAK for accreditation for the 2020-2021 period

was **15**



HEPDAK decided to evaluate the <u>5 programs</u> that were previously visited in 2020 and the remaining 10 programs were postponed to the 2021-2022 period



Applicants for HEPDAK Accreditation

 Since that nursing programs conducted distance education this dramatic change prevented the preparatory work of the programs to apply for accreditation, some nursing programs withdrew their applications.







THE FEATURES OF THE DISTANCE EDUCATION PROGRAM EVALUATION AND VIRTUAL SITE VISIT DIRECTIVE OF **HEPDAK**



□ Virtual visit cycle and duration will remain same as on site and a face-to-face visit.

☐ The virtual site visit will be adapted to the virtual environment

☐ Virtual site visits will continue with real-time synchronous communication where groups-documents are visually visible.



 A virtual document room wil be arranged by the institution.



The responsibility of arranging the technical infrastructure for video conferences to be used in the virtual site visit will belong to the institutions.




All visual interviews will not be recorded for confidentiality

VIRTUAL TRAINING PROGRAMS FOR EVALUATORS (10-12 AUGUST 2020)

 HEPDAK organized An Online Three Days Training Workshop for First time Evaluators and the current evaluators to prepare them for their role as virtual visitor and to orient them to the virtual site visit during accreditation processes.

In total, 32 evaluators participated

The participants were divided into small groups and worked together on a scenario of a self-evaluation report of a nursing programme, discussed and presented their work on these subjects to whole group.


Online Workshop For Training The Evaluators To Prepare Them Virtual Site Visits (Role Play Simulation) 13 Nov. 2020.

 All evaluators (academicians/nurse students), as well as representatives of five institutions to be evaluated in 2020-2021 attended this training


Online Workshop For Training The Evaluators To Prepare Them Virtual Site Visits (Role Play Simulation) 13 Nov. 2020.

 Before the training, a five-person teams were formed among the participants. In this simulation the participants assumed the roles of;

- ☐ The training was carried out in a simulated visit format over this animation
- The online workshop programme participants worked interactively on a scenario of a self-evaluation report in groups and shared their work results with the audience (in total 64 participants).





Evaluation of online training workshops

☐ The participants shared their feedbacks and evaluated the training programs as satisfactory, valuable and successful.

☐ These experiences could be recommended for the agencies if they are intending to plan and use virtual site visits

 Feedbacks and suggestions of team chairs and the evaluators regarding online evaluation process (evaluating the self evaluation reports, standards and program evaluation schedule, pre, post and virtual visit evaluation and Site Visit Directives) were gathered



POSITIVE FEEDBACK

- The virtual document room was very functional.
- Also, the video demonstrating the learning environment sent by the institutions were sufficient.

NEGATIVE FEEDBACK

- Virtual Evaluations were challenging.
- The online visit process was very tiring physically and mentally.
- Not as efficient as face-to-face interaction
- Interviews with students should be done with smaller groups and students should definitely turn

FUTURE IMPROVEMENTS

- Use of the virtual document room during the face-to-face visit may be effective
- Virtual site visit interviews can be considered as a mixed approach during face to face evaluations after the pandemic
